### ¿Who we are?

The Economic and Social Research Consortium (CIES) is an umbrella organization with 48 peruvian institutional members dedicated to investigation and teaching in economic and social science.

## **Purpose**

CIES seeks to strengthen Peruvian academia in order to produce and disseminate useful knowledge for analysts, policy makers, civil society, the media, international development agencies and academia.

### ¿What we do?

- Produce new and useful knowledge for the analysis, design, implementation, and evaluation of public policies and programs.
- Improve the quality and relevance of such research.
- Strengthen and decentralize the national capacity for research and teaching in economic and social issues.
- Foster dialogue and interaction among academia, the public sector and civil society.
- Promote recognition of and support for socio economic research in Peru.
- Obtain funds to support research.

# **Our history**

- The Consortium was created in 1989 as a Canadian project, named Economic Research Consortium (CIE).
- It was constituted of five peruvian research centers: CIUP, Desco, GRADE, IEP y PUCP.



## **Our history**

During its first decade the Consortium managed prevent brain drain, supported a critical mass of researchers which now have a major presence in the Peruvian scenario, accumulated knowledge base on key policy issues, promoted evidencebased dialogues and began approaching the public sector as an strategic stakeholder.



# **Our history**

In 1999 the Project became a national institution named CIES. It was legally constituted, first with 24 institutional members.



Nowadays CIES is a peruvian institution with 48 institutional members, including think tanks, research centres, NGOs, universities, private consultancies and public agencies.

# **CIES Annual Research Competition**

- Since 1999 CIES convenes an annual competition to fund new research on economic and social policies that generate evidence to contribute to better decision-making by the state.
- than 600 investigations, 200 publications and a wide range of seminars, debates, workshops and academic exchanges on economic and social policy.



### **CIES Annual Seminar**

It is the most important event in the Peruvian Academia where topics of national and international relevance are discussed and the winners of the Annual Research Competition are recognized.

Economic and social scientists meet together with public sector officials, businessmen, international cooperation and civil society actors to deliberate current issues from the perspective of policy options raised in the results of the studies commissioned to researchers from partner institutions of CIES through Annual Research Competition.



### CIES Annual Seminar

Aiming to enlighten the debate, exchange experiences and ensure multi-stakeholders engagement, CIES invites prestigious international and national key note speakers, experts of different political, academic, and social sectors.

The Annual Seminar has counted with the participation of three Nobel Prizes in Economics: Joseph Stiglitz, Finn Kydland and Oliver Williamson, who participated in 2007, 2008 and 2011 respectively.



#### **CIES Public Sector Consultative Group**

Group composed by senior representatives from public sector involved in economic and social policy.

- It is the reference group for the CIES research needs of the public sector. It seeks to strengthen the link between the academic community and the Peruvian State.
- Since june 2008, CIES has organized six meetings with the Public Sector Consultative Group.

## Impact on the Peruvian Parliament

#### Convention updating and dissemination of information to Congress

- Signed by the President of the Congress of the Republic of Peru.
- Objective: Spread information to the congressmen and various legislative committees on the basis of academic research and research summaries on economic and social issues.



 The signing of the document was made prior to the masterly conference of the Nobel Prize winning in Economic Sciences, Oliver Williamson, in the Congress.

# Peruvian Elections 2011 Project

The "Peruvian Elections 2011 Project: Centering the electoral debate" sought to strengthen the proposal capacity of political parties who participated on the electoral process in 2011, by incorporating 15 executive documents about relevant policy proposals for the elected government: "Contributions to the Peruvian Government 2011 – 2016".

This documents were elaborated by independent authors and included more than 50 policy proposals (economic, social and environmental) that were discussed in 25 meetings with 6 political parties and widely disseminated through public events in 8 major cities and in the national media (radio, TV and press coverage).

#### Organized by CIES and the National Jury of Elections



Presidential Debate in second round (ballotage) between Keiko Fujimori and the actual president Ollanta Humala

The confrontation of ideas between both candidates were broadcast live by all the national television channels and CNN, who spread the presidential debate to more than of 28 countries in Latin America and United States.

CIES coordinated the edition and publication of programmatic and presidential debates.



# STRENGTHENING THE CAPACITIES IN RESULT-BASED MANAGEMENT PROJECT

- **Duration:** December 2008 April 2012
- Funded by the European Union
- General objective: Strengthening the capacities of four Regional Governments of CIES's partners as well as civil society organizations (journalists and grassroots organizations) in Result-based Management, more effective, efficient and responsive to local actors' demands.

- The project has succeeded in training in Result-based Management to 295 officials of the public sector from Local and Regional Governments, 196 journalists and 724 civil society members from four regions of Peru through the implementation of the *Diploma in Result-based Management*. Most of public employees that attended the diploma continue working in their posts even though there was a change of authorities in 3 Regional Governments.
- 23 initiatives about education, health and nutrition have been generated; and each regional partner is working to have them implemented in their Regional and Local Governments.
- 6 base line about health, education, food security and childhood have been generated. It will allow to measure effectiveness on the management of the regions for each topic.
